Galls Automatic Knife Compliance Form

PLEASE READ CAREFULLY. THIS FORM MUST BE COMPLETED BEFORE GALLS, LLC ("GALLS") CAN SHIP ANY AUTOMATIC KNIFE

Please print, read and complete this page and fax with a copy of your government, state, or local law enforcement, military, EMT, Fire, or rescue personnel identification. Fax to Galls at **1-866-290-3389**.

Until both this completed form and appropriate identification are received by Galls, your order cannot be processed. Galls will sell automatic knives only in accordance with federal law (18 U.S.C. Section 1716(g)), which prohibits the mailing of automatic knives, with the following limited exceptions:

- (1) to civilian or Armed Forces supply or procurement officers and employees of the Federal Government ordering, procuring, or purchasing such knives in connection with the activities of the Federal Government;
- (2) to supply or procurement officers of the National Guard, the Air National guard, or militia of a state, territory or the District of Columbia ordering, procuring, or purchasing such knives in the connection with the activities of such organizations;
- (3) to supply or procurement officers or employees of any State, or any political subdivision of a State or Territory, ordering, procuring, or purchasing such knives in connection with the activities of such government; and
- (4) to manufacturers of such knives or bona fide dealers therein in connection with any shipment made pursuant of an order from any person designated in paragraphs (1), (2), and (3). The Postal Service may require, as a condition of conveying any such knife in the mails, that any person proposing to mail such knife explain in writing to the satisfaction of the Postal Service that the mailing of such knife will not be in violation of this section.

Galls must have proof of your eligibility under one or more of these exceptions before we can complete your order. Please note that state and local law may impose additional purchasing restrictions, and compliance with such additional restrictions is the responsibility of the purchaser. Galls makes no warranty of any kind, express or implied, including but not limited to fitness for a particular purpose. No sales to minors. By placing an order, the purchaser represents that the product(s) will be used in a lawful manner and that purchaser is of legal age. Galls is not liable for the misuse or unlawful use of any product.

By signing the statement below, you represent and warrant that you meet the eligibility requirements for the purchase of an automatic knife, you will use such products only for lawful purposes, and on behalf of your organization you are authorized to release and do release Galls and agree to hold it harmless from any and all claims, actions, damage, injury, or liability arising out of or related to the sale, shipment, possession, and/or use of such knives purchased from Galls.
